4. The bid must be submitted at Bhume Rural Municipality Office Rukum (East), Morawang, Nepal **not later than 12:00 hour noon on the** 31st day of first date of publication of this notice.

The accepted bid shall be opened at Bhume Rural Municipality Office Rukum (East), Morawang, Nepal in the presence of the bidder's representatives who choose to attend at **14:00 hours** on the last date of submission. Non attendance of any or all of the bidder's representatives shall not hinder the opening of the bids.
6. In case the last day of bid document purchasing & submission falls on government holiday then the same time on the next working day shall be considered for such events. In such case the bid and bid security validity shall be recognized with effect from the original bid submission deadline.
